**Original forms** are required to be received via mail **BEFORE** approval will be given. A copy will then be returned to the Fire Chief after approval is given via provided email address.

- Legal affidavit of ownership **MUST** be signed by all owners **BEFORE** a Notary Public and be forwarded to this office **BEFORE** the State Fire Marshal can approve the burning permit.
- Permission to burn will be granted **ONLY** to the chief of the local fire department and only **AFTER** written application is **APPROVED** by the State Fire Marshal in writing.
- Permit to Burn must be in the hands of the local fire chief before burning exercise is conducted.
- Fire Department and/or owner shall assume all liability for damage which might occur due to this burning exercise.
- Do not burn if it is windy or property to be burned is close to another person's building.
- Fire chief and firefighters, before departing from fire scene, **SHALL** and **MUST** extinguish **ALL** embers very thoroughly to prevent rekindling.
